- 1. Length of Perimeter: approximately 6.0KM, in forests area and near village
- 2. Number of Fence Strands: 2Nos(minimum)
- 3. The posts must be at 60° on top of MS angle
- 4. Purpose -to prevent the wild leopards to move/jump inside the boundary
