1. Intending bidder may download the tender documents from the website <https://wbtenders.gov.in> directly with the help of Digital signature Certificate.
2. Both **Technical Bid** and **Financial Bid** are to be submitted concurrently duly digitally signed in the website <https://wbtenders.gov.in>
3. Tender documents may be downloaded from website and submission of Technical Bid and Financial Bid should be done as per prescribed Time Schedule.
4. The **FINANCIAL OFFER** of the prospective tenderer will be considered only if the **TECHNICAL BID** of the tenderer is found qualified by the '**Tender Committee**' formed by the Director, North Bengal Wild Animals Park, Siliguri.
5. All prospective tenderer shall be allowed to participate in one or more than one of the above mentioned works in this notice. But separate application with supporting documents and EMD should be submitted separately for each work.
6. In case of any unscheduled holiday or bundh or natural calamity on the aforementioned dates, next working day will be treated as scheduled/prescribed date for the same purpose.
7. Tender inviting authority reserves the right to defer the time and date of opening of the Technical or Financial or both bids.

## 8. ELIGIBILITY CRITERIA FOR PARTICIPATION IN THE TENDER.

**8.1** The prospective tenders as a primary bonafide Contractor /Manufactures/ Agencies/Suppliers including Consortiums and Partnership firms having 3 (three) financial years experience from the date of issue of this tender notice of similar type of supply in Govt./PSU Sector/Zoological Garden / Autonomous Organization like Govt. aided college, University etc. with satisfactory performance are eligible to participate.

**8.2** To qualify for award of contract, each bidder in its name in last three financial years should have achieved a minimum annual financial turnover of similar nature of work of not less than (i) 50% of the estimated cost of work for a single similar nature of work credential (ii) 75% estimated cost of work for two similar nature of work credentials or (iii) 100% estimated cost work for three similar nature of work credentials. Bidder are required to submit Income tax return acknowledgement , audited balance sheet and P & L accounts for last 3 (three) financial years along with Technical Bid.

**8.3** **Document:** Income Tax Acknowledgement Receipt for the latest Assessment year, P.T. Deposit Challan for the latest Assessment year, PAN Card, GST Registration Certificate, Bank Solvency certificate, Trade license (valid), Fully filled Application form are to be accompanied with the Technical Bid Documents.

**[Statutory documents]**

**8.4** Bidders are required to have Trade Licence, P-Tax Registration and GST Registration with Government of West Bengal.

**8.5** **Affidavit (Y):** Neither prospective Tenderer nor any of the constituent partner had been debarred to participation in any Tender by the State/Central Government, State/Central Government undertaking. Statutory/Autonomous bodies constituted under the Central/State statute during the last 5 (five) years prior to the date of this NIT. Such debarring will be considered as disqualification towards eligibility. (A declaration in this respect has to be furnished by the prospective bidders as per prescribed format in non-judicial stamp paper, must be uploaded with both side of Stamp Paper-Affidavit-Y).

**(Non-Statutory documents)**

**8.6** Registered Labour Co-operative Societies are required to furnish valid Bye Law, Current Audit Report, Minutes of last A.G.M (preferably), valid certificate from A.R.C.S. along with other relevant supporting papers and be submitted along with technical bid.

9. Bid shall remain valid for a period of 90 days from the first date of closing. If the bidder withdraws the bid during the validity period of bid, the earnest money as deposited will be forfeited forthwith without assigning any reason thereof.

## 10. EARNEST MONEY DEPOSIT AND TENDER DOCUMENT COST.

### **(a) Payment procedure:**

#### **Payment by Net Banking (any listed bank) through ICICI Bank Payment Gateway:**

On selection of net banking as the payment mode, the bidder will be directed to ICICI Bank Payment Gateway webpage (along with a string containing a Unique ID) where he will select the Bank through which he wants to do the transaction. Bidder will make the payment after entering his Unique ID and password of the bank to process the transaction. Bidder will receive a confirmation message regarding success/failure of the transaction. If the transaction is successful, the amount paid by the bidder will get credited in the respective Pooling account of the State Government /PSU/Autonomous Body/Local Body/PRIs, etc maintained with the Focal Point Branch of ICICI Bank at R.N. Mukherjee Road, Kolkata for collection of EMD/Tender Fees. If the transaction is failure, the bidder will again try for payment by going back to the first step.

**(b) Payment through RTGS/NEFT:**

- (i) On selection of RTGS/NEFT as the payment mode, the e-Procurement portal will show a pre-filled challan having the details to process RTGS/NEFT transaction.
- (ii) The bidder will print the challan and use the pre-filled information to make RTGS/NEFT payment using his Bank account. Once payment is made, the bidder will come back to the e-Procurement portal after expiry of a reasonable time to enable the NEFT/RTGS process to complete, in order to verify the payment made and continue the bidding process.
- (iii) If verification is successful, the fund will get credited to the respective Pooling account of the State Government/PSU/ Autonomous Body/Local Body/PRI, etc maintained with the Focal Point Branch of ICICI Bank at R.N. Mukherjee Road, Kolkata for collection of EMD/Tender Fees.
- (iv) Hereafter, the bidder will go to e-Procurement portal for submission of his bid. But if the payment verification is unsuccessful, the amount will be returned to the bidder's account.

**(C)Refund/Settlement Process:**

- I. After opening of the bids and technical evaluation of the same by the tender inviting authority through electronic processing in the e-Procurement portal of the State Government, the tender inviting authority will declare the status of the bids as successful or unsuccessful which will be made available, along with the details of the unsuccessful bidders, to ICICI Bank by the e-Procurement portal through web services.
- II. On receipt of the information from the e-Procurement portal, the Bank will refund, through an automated process, the EMD of the bidders disqualified at the technical evaluation to the respective bidders' bank accounts from which they made the payment transaction. Such refund will take place within T+2 Bank Working Days where T will mean the date on which information on rejection of bid is uploaded to the e-Procurement portal by the tender inviting authority.
- III. Once the financial bid evaluation is electronically processed in the e-Procurement portal, EMD of the technically qualified bidders other than that of the L1 and L2 bidders will be refunded, through an automated process, to the respective bidders' bank accounts from which they made the payment transaction. Such refund will take place within T+2 Bank Working Days where T will mean the date on which information on rejection of financial bid is uploaded to the e-Procurement portal by the tender inviting authority. However, the L2 bidder should not be rejected till the LOI process is successful.
- IV. If the L1 bidder accepts the LOI and the same is processed electronically in the e-Procurement portal, EMD of the L2 bidder will be refunded through an automated process, to his bank account from which he made the payment transaction. Such refund will take place within T+2 Bank Working Days where T will mean the date on which information on Award of Contract (AOC) to the L1 bidder is uploaded to the e-Procurement portal by the tender inviting authority.
- V. As soon as the L1 bidder is awarded the contract (AOC) and the same is processed electronically in the e-Procurement portal EMD of the L1 bidder for tenders of State Government offices will automatically get transferred from the pooling account to the State Government deposit head "8443-00-103-001-07" through GRIPS along with the bank particulars of the L1 bidder. EMD of the L1 bidder for tenders of the State PSUs/Autonomous Bodies/Local Bodies/PRI, etc will automatically get transferred from the pooling account to their respective linked bank accounts along with the bank particulars of the L1 bidder. In both the above cases, such transfer will take place within T+1 Bank Working Days where T will mean the date on which the Award of Contract (AOC) is issued.

The Bank will share the details of the GRN No. generated on successful entry in GRIPS with the E-Procurement portal for updation. Once the EMD of the L1 bidder is transferred in the manner mentioned above, Tender fees, if any, deposited by the bidders will be transferred electronically from the pooling account to the Government revenue receipt head "0070-60-800-013-27" through GRIPS for Government tenders and to the respective linked bank accounts for State PSU/Autonomous Body/Local Body/PRIs, etc tenders.

All refunds will be made mandatorily to the Bank A/c from which the payment of EMD & Tender Fees (if any) were initiated. There is no exemption of any kind for any of the eligible contractors towards cost of tender document fee or EMD.

11. Both technical Bid and Financial Bid should be submitted duly digitally signed by the Tenderer through the website <http://wbtenders.gov.in> as per the 'Date & Time Schedule' stated in this NIT (Details of which has been narrated in '**Instruction to Bidders**') In case of partnership firm(s), the pledged instrument (s) must reflect the name(s) of the firm as well as the name(s) and address(es) of the partner/partners who is/are authorized to pledge the same as per valid partnership deed (s).
12. **Security Deposit** - EMD submitted by successful bidder shall be converted as part of the security deposit. Remaining part of the Security Deposit of the accepted tender value will be adjusted from the bill of the contractor. No interest will be paid on Security Deposit (SD) by the authority.
13. Additional Performance Security (APS) - As per Finance Deptt. Govt. of West Bengal order no 4608-F(Y) dated 18.07.2018, if the bid value becomes 80% or less of the estimated value put to tender, APS shall have to be submitted @ 10 % of the tendered amount in the form of Bank Guarantee from any scheduled bank in favor of Director, NBWAP, Siliguri before issuance of the work/supply order. If the bidder fails to submit the APS within seven days, his earnest money shall be forfeited. The bank guarantee shall have to be valid up to end of contract period and shall be renewed if required.

## **INSTRUCTION TO BIDDERS**

### **01. General guidance for e-Tendering:-**

Instructions / Guidelines for electronic submission of the tenders have been annexed for assisting the contractors to participate in e-Tendering.

**i) Registration of Contractor:-** Any contractor willing to take part in the process of e-Tendering will have to be enrolled & registered with the Government e-Procurement System, through logging on to <https://wbtenders.gov.in> The contractor is to click on the link for e-Tendering site as given on the web portal.

**ii) Digital Signature certificate (DSC):** Each contractor is required to obtain a Class-II or Class-III Digital Signature Certificate (DSC) for submission of tenders from the approved service provider of the National Informatics Centre (NIC) or other certified agencies of Government of India on payment of requisite amount. Details are available on the Web Site. DSC is given as a USB e-Token.

**iii)** The contractor can search & download N.I.T. & Tender Document(s) electronically from Computer once he logs on to the website by using the Digital Signature Certificate (DSC). This is the only mode of collection of Tender Documents.

**iv) Participation in more than one work:** A prospective bidder shall be allowed to participate in the job either in the capacity of individual or as a partner of a firm.

**v) Submission of Tenders:-** Tenders are to be submitted through online to the website in two folders at a time for each work, one in Technical Proposal & the other is Financial Proposal before the prescribed date & time using the Digital Signature Certificate (DSC). The documents are to be uploaded virus scanned copy duly digitally signed. The documents will get encrypted (transformed into non readable formats).

**vi) Technical Proposal:** The Technical proposal should contain scanned copies and/ or declarations in the following standardized formats in two covers (folders)

**02. Technical file (Statutory Cover) containing the following documents:-**

- i. Application for Tender- (Vide form -1) (to be submitted in “Forms” folder)
- ii. Tender Form No. A – Form A published with the NIT to be downloaded and then uploaded and digitally signed. (to be submitted in “Forms” folder).
- iii. Notice Inviting Tender (NIT) – The NIT as published is to be downloaded and then uploaded and digitally signed. (to be submitted in “Forms” folder).
- iv. Earnest Money Deposit (EMD) – should be deposited through e-procurement system.

Average annual turnover form contracting business – Scanned copy of summary statement of average annual turnover from contracting business for a period of last three years, i.e. 2020-21, 2021-22 & 2022-23 or during the period since formation of the firm, if it was set up in less than such 3 year period (Vide form-2) (to be submitted in “Forms” folder).
- vi. Declaration of not having common interest in the same serial – (Vide form-3) (to be submitted in “Forms” folder).
- Vii. Drawing if any. (to be submitted in “Forms” folder).

**(b) Financial Proposal**

The financial proposal should contain the following document in one cover (folder).

Bill of Quantities (BOQ) :- The intending tenderers are to quote rate per day only for the Hiring of Vehicle at North Bengal Wild Animals Park online through computer in the space marked for quoting rate/price in the BOQ. (Only downloaded copies of the above documents are to be uploaded, virus scanned and digitally signed by the contractor).

**(c) Submission of original copies of documents of Tender Cost and Earnest Money Deposit**

Mode of payment:- Earnest Money Deposit (EMD) at a rate as prescribed in Clause- 1 as per existing Government Order No. 3975-F (Y) Dated 28<sup>th</sup> July, 2016 through State Government e-procurement portal.

**(d) Eligibility Criteria**

Financial proposal of any contractor will come under the purview of consideration only if all the criteria 4(a, b, c, 7 d) mentioned below are fulfilled.

- 4 (a)** Bonafide Manufacturers/Agencies/Suppliers, including Consortiums and Partnership firms having experience of completion of similar type of work during the last 3 financial years for a contract of value not less than 50% of the estimated value of the Tender.
- i. Completion certificate(s) submitted by the bidder should indicate the gross value of 100% completed work only. Completion certificate should clearly contain the Name, Designation, address, and contact no of the Officer issuing the credential.
  - (b) Average annual turnover from contracting business as stated in the Form-2 should be at least 50% of the amount put to tender of the works in which the contractor intends to participate.
  - (c) The bidder or any of their constituent partners shall neither have abandoned any work nor have any of their contracts been rescinded during the last 3 years. Such abandonment or recession will be considered as disqualification towards eligibility.
  - (d) Tender issuing authority may relax stipulations contained in clauses above in exceptional cases, in the interest of culminating/ maturing tender process at the first call, subject to satisfaction of that authority on the competency of the bidder(s) for which such relaxation has been made, upon recording reasons of such relaxation.

**05. Important Conditions.**

**5.1 Completion Certificate**

Completion certificates for fully (100%) completed work during the current financial year and the last five financial years will only be accepted. Certificates issued for partly completed works will not be considered.

## **5.2 Penalty for suppression/distortion of facts**

If any tenderer fails to produce the original hard copies of the documents (especially Completion Certificates and audited balance sheet), or any other documents on demand of the Tender Accepting Authority (TAA) within a specific time frame or if any deviation is detected in the hard copies from the uploaded soft copies or if there is any suppression, the tenderer will be suspended from participating in the tenders on e- Tender platform of the Directorate of Forests, Government of West Bengal for a period of 3 (Three) years. In addition, his Earnest Money Deposit will stand forfeited to the Government. Besides, the Director, North Bengal Wild Animals Park, Siliguri may take appropriate legal action against such defaulting tenderer.

## **5.3 Taxes & duties to be borne by the Contractor**

Income Tax, GST, Sales Tax, Service tax, Royalty, Construction Workers' Welfare Cess, and similar other statutory levy/cess will have to be borne by the contractor and the rate should be quoted inclusive of all these charges.

## **5.4 Site inspection before the submission of tender**

Before submitting any tender, the intending tenderers should make themselves acquainted thoroughly with the local conditions prevailing site by actual inspection of the site and take into consideration of all factors and difficulties likely to be involved in the execution of work on all respects including transportation and delivery of materials, communication facilities, climate conditions, nature of soil, availability of local labour and market rate prevailing in the locality etc. and no claim, whatsoever, will be entertained on this account afterward. In this connection intending tenderers may contact the office of the Director, North Bengal Wild Animals Park, 5<sup>th</sup> Mile Sevoke Road, Salugara, Siliguri, jalpaiguri-734008 between 10.30 hours to 05.00 hours on any working day before the date of submission of tenders.

## **5.5 Conditional and incomplete tender**

Conditional and incomplete tenders are liable to summary rejection.

## **06. Opening and evaluation of tender**

### **6.1 Opening and Technical Proposal.**

- i. Technical proposals will be opened by the Director, North Bengal Wild Animals Park, Siliguri, or his authorized representative electronically from the website stated in Clause 2.
- ii. Technical proposals for those tenders who's EMD through the e-procurement system have been received will only be opened. Proposals corresponding to which the EMD have not been received will not be opened and will stand rejected.
- iii. Intending tenderers may remain present if they so desire at the Director, North Bengal Wild Animals Park, Siliguri.
- iv. Cover (Folder) for Statutory Documents (vide Clause 7.2 A) would be opened first and if found order, Cover (Folder) for Non-statutory Documents (vide Clause 7.2 B) will be opened. If there is any deficiency in the Statutory Documents, the tender will summarily be rejected.
- v. Decrypted (transformed into readable formats) documents of the Non-statutory Cover will be downloaded, by the Tender Accepting Authority.
- vi. The tenderers for which the Technical proposals are found to be in order shall only quantify for opening of financial bid.

### **6.2 Provision for its appeal and its disposal.**

- i. Intending tenderers not satisfied with the decision of the Tender Accepting Authority (TAA) may prefer an appeal to the Director, North Bengal Wild Animals Park, Siliguri West Bengal, within two working days after the date of uploading if the summary list of the successful tenderer. Copy of such appeal should also be sent to the Tender Inviting Authority.
- ii. The Appellate Authority, i.e. The Director, North Bengal Wild Animals Park, Siliguri, West Bengal, will dispose of such appeals by hearing the aggrieved tenderers as well as consulting with the Tender Accepting Authority within a reasonable time and the tenderer will be communicated accordingly.

### **6.3 Opening and evaluation of the final proposal.**

- i. Financial proposals of the tenderers declared technically eligible by the Tender Accepting Authority will be opened electronically from the web portal stated in Clause 2 on the prescribed date.
- ii. The encrypted copies will be decrypted and the rates will be read out to the contractors present at that time.
- iii. After the evaluation of Financial Proposal, by the Director, North Bengal Wild Animals Park, Siliguri or his authorized representative or Committee, the final summary result will be uploaded to the website, which inter-alia will contain, names of contractors and the rates quoted by them against each work.
- iv. The Tender Accepting Authority, if required, may ask any of the tenderers to submit analysis to justify the rate quoted by the tenderer.

### **6.4 Procedure to be followed when one/two technically qualified tenderers participate in any tender.**

- i. Financial bid of technically qualified single/two tender(s) will not be opened immediately.
- ii. 2<sup>nd</sup> call will be invited immediately after technical evaluation after uploading a list of the technically qualified bidder(s) of the 1<sup>st</sup> call.
- iii. If such bidder(s) technically qualified in the 1<sup>st</sup> call intends to change their rates quoted in the 1<sup>st</sup> call, they need to submit fresh tender. However fresh EMD need not be submitted and EMD submitted earlier will be considered. In case of non-submission of fresh tender fee in the 2<sup>nd</sup> call, the rates quoted in the 1<sup>st</sup> call would remain valid while the bid submitted in the 2<sup>nd</sup> call will be rejected.
- iv. After the selection of technically qualified tenders for 2<sup>nd</sup> call (in case new tenderer other than the existing tenderer of the 1<sup>st</sup> call), the financial bid of both 1<sup>st</sup> and 2<sup>nd</sup> call would be opened.
- v. Financial evaluation would be made in a combined way considering both 1<sup>st</sup> and 2<sup>nd</sup> call.
- vi. However, incase tenderer(s) of 1<sup>st</sup> call submit(s) fresh tender in 2<sup>nd</sup> call, rates of 2<sup>nd</sup> call will only be opened and considered in the process of evaluation.

**07. Bid Validity:** The Bid validity for 365 days from the date of opening of the final bid.

### **08. Acceptance of Tender.**

Lowest valid rate should normally be accepted. However, the Tender Accepting Authority does not bind himself to do so and reserves the right to reject any or all the tenders, for valid reasons and also reserves the right to distribute the work amongst more than one tenderer.

### 8.1 Execution of Formal tender after acceptance of tender.

The tenderer whose tender is approved for acceptance, shall within 7 days of the receipt of “Work Order” (WO), will have to execute ‘Formal Agreement’ with the Tender accepting authority in quadruplicate copies.

### 8.2 Return of Earnest Money of the unnecessary tenderer(s)

Return of the Earnest Money Deposit of the successful as well as unsuccessful tenderer(s) will be made as per existing Government Order No 3975-F (Y) Dated 28<sup>th</sup> July 2016 through State Government e-procurement portal.

### 8.3. Force Majeure:

The tenderer/ contractor shall not be considered in default, if delay in execution of work occurs due to causes beyond his control, such as acts of God =, natural calamities, civil wars, strikes, frost, floods, riots, and acts of unsurpassed power. In the event of delay due to such causes, the contract may be extended for a length of time equals to the period of force majeure or at the option of the Director, North Bengal Wild Animals Park, Siliguri, it may be cancelled. Such cancellation would be without any liability whatsoever on the part of Society.

## **09. THE ABOVE STATED NON-STATUTORY/STATUTORY DOCUMENTS (TECHNICAL BID) WILL BE EVALUATED IN THE FOLLOWING MANNER**

- 1) Specification of vehicle
  - a. BS VI CNG Bus having air conditioning system
  - b. Length – 6.55m (From front face to back face)
  - c. Breadth - 2.2m (From outer side to outer side)
  - d. Seating capacity-  $20 + D/22 + D$
  - e. Wheels and tyres – Radial with tube/tubeless (6 + 1)
  - f. Glass specification – Visibility should be priority. Window glass shall be wide, concealed having good visibility.
  - g. Bus doors shall have powerful and best quality locking system, Door to be controlled by pilot.
  
- 2) Supply of fuel and driver for bus and all sorts of repairing works shall be the responsibility of the bidder.
  
- 3) The present requirement of Buses is to be obtained as per work schedule and not to run during holiday as of declared or mentioned there in. However, Tender Inviting Authority may increase or decrease the number of buses during the period of contract on the same rates, terms and conditions as fixed based on the rates.

Copy of last assessment order duly certified as true copy by the chartered accountant shall also be submitted.

  - 2.4 if the partnership deed do not speak of percentage share of each partner, it shall not be considered as Credential for qualifying Eligibility criteria.
- 03 **IN CASE OF COMPANIES:** Date and place of registration including date of commencement certificate in case of public companies and the nature of business carried out by the Company. Certified copies of memorandum and Articles of Association are also to be furnished. Also indicate names, addresses and experience of the Directors.

**04. RETURN OF SECURITY DEPOSIT:** If the contractor fully performs and completes the work in all respects to the entire satisfaction of NBWAP and presents an absolute "**No Demand Certificate**" in the prescribed form and returns properties belonging to WBZA taken, borrowed or hired by him for carrying out the said works and shall be released only after the Guarantee Period of 12 months is completed satisfactorily. No interest shall be payable by NBWAP on Earnest Money Deposit, Security Deposit or on any moneys due to the contractor.

#### **5.0 COMMENCEMENT AND COMPLETION OF WORK**

5.1 The contractor shall commence the work within the time indicated in the Letter of Intent / acceptance and shall proceed with the same with due expedition without delay. The responsibility of successful tenderer under this Contract commences from the date of issue of the Letter of Intent.

5.2 If the successful tenderer fails to commence the work within the stipulated time, NBWAP, at its sole discretion, will have the right to terminate the contract. The Security Deposit will stand forfeited without any further reference to him without prejudice to any and all of NBWAP other rights and remedies in this regard.

5.3 All the works shall be carried out under the direction and to the satisfaction of the Director NBWAP Siliguri.

#### **6.0 MEASUREMENT OF WORK AND MODE OF PAYMENT**

6.1 All payment shall be made in the name of contractor by Account's Payee Cheque.

6.2 For progress/ running bill payments, the contractor shall present detailed measurement book and sheets in triplicate duly indicating all relevant details based on technical documents and connected drawings for the work done during the month. These measurement sheets shall be prepared jointly with Engineer and signed by both the parties.

6.3 These measurement sheets will be checked by the Engineer and quantities and percentages eligible for payment under different groups shall be decided by him. The abstract of quantities and percentages so arrived at based on the terms of payment shall be entered in the **Measurement Book** and signed by both the parties.

6.4 Based on the above quantities, contractor shall prepare the bills in the prescribed Performa and work out the financial value. These will be entered in the Measurement Book and signed by both the parties. Payment shall be made after affecting the necessary recoveries due from the contractor.

6.5 Measurement shall be taken jointly by persons duly so authorised by the Director WBZA and the Contractor and shall follow the relevant provisions of IS code and PWD / SOR 2015 for recording and taking measurements.

6.6 The Contractor shall bear the expenditure involved, if any, in making the measurements and testing of materials to be used/ used in the work. The Contractor shall, without extra cost to NBWAP, provide all the assistance with appliances and other things necessary for measurement.

6.7 If, at any time due to any reason whatsoever, it becomes necessary to re-measure the work done, in full or in part, the expenses towards such re-measurement shall be borne by the Contractor.

6.8 Final measurement bill shall be prepared in the Performa prescribed for the purpose, based on the certificate issued by the Engineer that the entire work as stipulated in the tender specifications has been completed in all respects to the entire satisfaction of WBZA. The Contractor shall give 'No Claim' and 'No Demand' certificates. All the tools and tackles loaned to him should be returned in condition satisfactory to NBWAP. The abstract of final quantities and financial values shall also be entered in the Measurement Book and signed by both the parties.

## **7.0 RESPONSIBILITIES OF CONTRACTOR IN RESPECT OF LOCAL LAWS, EMPLOYMENT OF WORKERS, ETC.**

The following are the responsibilities of the Contractor in respect of observance of local laws, employment of personnel, payment of taxes etc.

- 7.1 As far as possible, unskilled workers shall be engaged from the local areas in which the work is being executed.
- 7.2 The contractor at all times during the continuance of this contract, shall in all his dealings with the local labour for the time being employed on or in connection with the work, has due regard to all local festivals, religious and other customs.
- 7.3 The Contractor shall comply with all State and Central Laws, Statutory Rules, Regulations, etc., such as The payment of wages Act, The Minimum Wages Act, The workmen's Compensation Act, The Employer's Liability Act, The industrial Disputes Act, and other Acts, Rules and Regulations for labour as may be enacted by the Government during the tenure of the Contract and having force or jurisdiction at site. The contractor shall give to the local Governing Body, Police and other concerned Authorities all such notice as may be required under law.
- 7.4 The Contractor, in the event of his engaging 20 or more workmen, will obtain independent license under the Contract Labour (Regulations and Abolition Act, 1970) from the concerned authorities based on the certificate (Form-V) issued by the principal employer.
- 7.5 The contractor shall pay all taxes, fees, license charges, deposits, duties, tolls, royalty, commissions or other charges which may be liveable on account of any of his operations connected with this contract. In case NBWAP make any such payment, it shall be recovered from the contractor bill.
- 7.6 The contractor shall be responsible for the provision of health and sanitary arrangements more particularly described in the Contract Labour (Regulations and Abolition Act, 1970) and safety precautions as may be required for safe and satisfactory execution of the contract.
- 7.7 The contractor shall be responsible for proper accommodation including adequate medical facilities for the personnel employed by him.
- 7.8 The contractor shall be responsible for the proper behaviour and observance of all regulations by the staff employed by him.
- 7.9 The contractor shall ensure that no damage is caused to any person / property of other parties working at site. If any such damage is caused, it shall be the responsibility of the contractor to make good the losses and compensate them.

- 7.10 Any delay in completion of works or non-achievement of periodical targets, due to reasons attributable to the contractor, will have to be compensated by the contractor either by increased manpower and resources at no extra cost to NBWAP.
- 7.11 The contractor will be directly responsible for payment of wages to his workmen. A pay-roll sheet giving details of all payments made to the workmen duly signed by the contractor's representative should be furnished to the Director, NBWAP, if called for.
- 7.12 In case of any class of work for which there is no specification laid down in the contract, such work shall be carried out in accordance with the instructions and requirements of the Engineer.
- 7.13 **No idle labour charges** will be admissible in the event of any stoppage of work resulting in the contractor's workmen being rendered idle due to any reason at any time.
- 7.14 The contractor shall keep the area of work clean and shall remove the debris etc while executing day-to-day work.
- 7.15 The contractor shall execute the work in the most substantial and workman like manner in the stipulated time. Accuracy of work and timely execution shall be the essence of this contract.
- 7.16 No land belonging to WBZA shall be occupied by the Contractor without written permission of the Director, NBWAP.

#### **08. METHOD OF MEASUREMENT-**

Method of measurements shall be as per standard specification included in the tender. For other items, measurement shall be as per relevant IS CODE.

### **PART – C** **GENERAL TERMS AND CONDITIONS**

#### **1.0 DEFINITION OF TERMS**

Throughout the Tender Documents including the Enquiry Letter, the following words shall have the meanings assigned to them herein, unless the subject matter or the context requires otherwise.

- 1.1 The '**Purchaser**' or 'NBWAP' shall mean North Bengal Wild Animals Park, West Bengal Zoo Authority incorporated under the Companies Act 1956, with its Registered Office at 5<sup>th</sup> Mile, Sevoke Road, Salugara, Siliguri, Dist-Jalpaiguri-734008, which expression shall include its successors and assigns; acting through its Fabrication Plant (FP), or its authorized officers or its Engineer or other employees authorized to deal with any matters with which these persons are concerned, on its behalf.
- 1.2 The '**Tenderer**' shall mean the Firm/Company/Organisation, which quotes against the Tender Enquiry issued by the Purchaser. It may also be referred as '**Bidder**'.
- 1.3 The '**Contractor**' shall mean the individual, firm or company whose Offer is accepted by NBWAP and enters into Contract with NBWAP and shall include their executors, administrators, successors and permitted assigns.

- 1.4 The **'Contract'** shall mean and include the agreement, the work order, the accepted appendices of rates, Schedules of Quantities, if any, General Conditions of Contract, Special Conditions of Contract, Instructions to Tenderers, the drawings, the technical specifications, the special specifications, if any, the tender documents and the Letter of Intent/ Acceptance letter issued by NBWAP. Any conditions or terms stipulated by the Tenderer in the tender documents or subsequent letters shall not form part of the Contract unless specifically accepted in writing by NBWAP in the Letter of Intent and incorporated in the Agreement. It may also be referred as **'Contract Document'**.
- 1.5 The **'Sub-contractor'** shall mean the person/firm/company/organisation to whom any part of the work has been sub-contracted by the Supplier, with the written consent of the Purchaser and shall include his heirs, executors, administrators, representatives and assigns.
- 1.6 The **'Engineer'**, for the purpose of this Contract shall mean an engineer, person or company duly appointed as such from time to time or such other officials as may be duly authorised and appointed and notified in writing by purchaser to act as engineer. In cases where no such Engineer has been so appointed, the word 'Engineer' shall mean the Purchaser or his duly authorised representative. It may also be referred to as **Engineer –in –Charge**.
- 1.7 The **'Equipment'** shall mean and include plant and stores on which work is to be done by the Contractor under the Contract.
- 1.8 The **'Work'** shall mean and include supply of all categories of labour, specified consumables, tools and tackles required for complete and satisfactory construction, site transportation, handling, stacking, storing, erecting, testing and commissioning of the equipment; as defined in the Tender Documents, to the satisfaction of NBWAP. It may also be referred as **'CONTRACT WORK'**.
- 1.9 The **'Tender Document'** shall mean and include the instruction to Tenderers, general conditions, bidding conditions, specific conditions, specifications, schedules, form of tender, schedule of prices and quantities, contained in the Tender and any subsequent modifications thereof. It may also be referred as **'Tender Specification'**
- 1.10 The **'Offer'** shall mean and include the technical and commercial documents including specifications, schedule of prices and quantities, etc submitted by the Tenderer in response to the tender enquiry and any subsequent clarifications thereof. It may also be referred as **'Bid'**.
- 1.11 **'Acceptance of offer'** shall mean issue of letter of intent/award or memorandum or detailed Order/Contract communicating the acceptance of offer, to the successful Tenderer.
- 1.12 The **'Letter Of Intent'** shall mean the intimation by a letter / fax to the Tenderer that the tender has been accepted in accordance with provisions contained in the letter. The responsibility of the contractor commences from the date of issue of this letter and all the terms and conditions of contract are applicable from this date.
- 1.13 The **'Site'** shall mean the site of the proposed work at place for which NIT published by the DIRECTOR NBWAP/WBZA.
- 1.14 The **'Completion Time'** shall mean the period specified in the Letter of Intent or date mutually agreed upon for completing the work to the satisfaction of the Engineer, being

of required standard and conforming to the specifications of the Contract including extension period.

- 1.15 The 'Tests' shall mean and include such test or tests to be carried out by the Contractor as are prescribed in the Contract or considered necessary by the Director WBZA in order to ascertain the quality, workmanship, performance and efficiency of the contracted work or part thereof.

## **ADDITIONAL TERMS & CONDITIONS**

Notwithstanding anything contained in the form in which the contract is executed, the following shall constitute terms and conditions of contract and shall be binding on the contractor.

1. All correspondence concerning rates, claims, change in specification and/or design and similar important matters will be valid only if made with the Director, North Bengal Wild Animals Park, Siliguri. If any correspondence of above tender is made with Officers other than the Director, North Bengal Wild Animals Park, Siliguri for speedy execution of work, the same will not be valid. In case of dispute, the decision of the Director, North Bengal Wild Animals Park, Siliguri shall be final and binding.
2. The acceptance of the tender including the right to distribute the work between two or amongst more than two tenderer will rest with the competent authority without assigning reason thereof. The accepting authority reserves right to reject any or all tenders without assigning any reason thereof.
3. The tenderer shall have to comply with the provisions of Motor Vehicle Act, 1988 and rules made there under a) Contract labour (Regulation & Abolition) Rules, 1970 (b) Minimum Wages Act 1948 or the modification thereof or any other laws relating thereto as well be in force from time to time.
4. The Tender Inviting Authority of the Society shall not be held liable for any compensation due to machines becoming idle for any circumstances including untimely rains, other natural calamities, strikes etc.
5. No Price preference will be applicable to W.B. Govt. Undertaking, as per Finance Dept. G. O. No. 8648-F(Y), dated 12<sup>th</sup> October 2012.
6. Imposition of any duty/ tax rules etc. whatsoever of its nature (after work order/ Commencement and completion of the work) is to be borne by the tenderer.
7. No mobilization/ secured advance bill will be allowed.
8. GST/Sales Tax, Cess, Toll Tax, Income Tax, Ferry Charges and other Local Taxes if any are to be paid by the contractor. No extra payment will be made for these. The rates of supply and finished work items are inclusive of these.

9. All buses should be registered in the name of Contractor/bidder/firm.
10. The contractor should visit the location of work and satisfy himself of the condition and nature of work and ascertain difficulties that might be encountered in executing the work, carrying materials to the site of work, availability of drinking water and other human requirements and security etc. The Officer-in-Charge may order the contractor to suspend any work that may be subjected to damage by climatic conditions. No claim will be entertained on this account.
11. The Authorized Officer of the office of the Director, North Bengal Wild Animals Park, Siliguri will monitor the work from time to time or every day. The design and specification of work should be done under his guidance. All the materials used in construction should be approved by him before use in construction.
12. In case any clarification is required, the interpretation of the Director, North Bengal Wild Animals Park, Siliguri will be final.
13. The final acceptance of the tender will be subject to the receipt of approval of higher authorities.
14. Final payment will be made after completion of all works in the field & checking by authorized officer. The authorized officer may check the quality of the work at any point of time before submitting the report of completion.
15. The undersigned reserves the right to cancel the agreement at any point of time during the execution of the work if it not done as per the specifications or any terms & conditions are violated by the Contractor.
16. The successful tenderer will not assign any or part of the work(s) to any other contractor/agency.
17. The acceptance of the tender will be subject to the receipt of the approval of the higher authorities and availability of fund. The undersigned will not be responsible for any loss sustained by the Tenderer in the event of non-receipt of Government sanction.
18. The payment of bill for any work will be made according to the availability of fund and approval of higher authorities wherever applicable and no claim to delay in payment will be entertained.
19. The terms and conditions of this "Tender Notice inviting tender" is part and parcel of the contract form.
20. All works are required to be carried out as per plan and specification & estimate of the project subject to the modification by the undersigned at any point of time during execution of the work duly notified to the contractor/ suppliers, within the project cost.
21. Statutory Deduction: Income Tax, GST, Labour Welfare Cess as applicable shall be deducted from the Gross mount of Bill.
22. During the inspection by the undersigned or by his representative, if the condition of any bus is not found upto the standard (pre-fixed), the contractor/ supplier is bound to rectify the same and another latest model bus as per specification mentioned herein before supply upto the

satisfaction of the undersigned or his representatives. Otherwise, the work order will be cancelled and the security deposit will be forfeited to the Government of West Bengal.

23. Minimum wage rule of the Government should strictly be followed.
